



Greetings Brothers and Sisters.

At 7:00 pm on Friday, November 3<sup>rd</sup>, 2017 there will be a special meeting held at the Union hall (760 N. Lamb Las Vegas, NV. 89110) with the purpose of nominating candidates for all offices. These offices are;

You must be a member in good standing to nominate a fellow member for office, and each member may only nominate one candidate per office. A member must be in good standing for the two continuous years prior to November 2<sup>nd</sup>, 2017 to be eligible to run for office. All members who are nominated for office must accept the nomination in person at the time of the meeting, or have submitted a notification of acceptance of nomination to a specific office prior to the conclusion of the nomination process. There will be a candidate meeting immediately following the nomination meeting where candidates, or their designee, will participate in a lottery for ballot placement. The election will be conducted by mail in ballot and administered by UniLect. The timeline for the election will be as follows;

November 3<sup>rd</sup> – Nominations for office and verification of candidate eligibility

November 9<sup>th</sup> – Ballots will be mailed out by UniLect

December 8<sup>th</sup> – Final day to request a duplicate ballot

December 16<sup>th</sup> – Counting of the ballots at the Union hall, and announcement of results

January 20<sup>th</sup> – Runoff election ballot count date in case of a tie vote

To be eligible to vote a member must have been in good standing for the continuous year prior to November 2<sup>nd</sup>, 2017. The eligibility list will be made available for a candidate to review one time after the nomination meeting. Candidates, or their designee, will be allowed to observe all steps of the election process. If you have not received your ballot by November 16, 2017, or if your ballot is spoiled in any way, you can request a duplicate by contacting UniLect Election Services Call Center toll free at 1(855) 240-0363. Operators are standing by 24/7 throughout the election period. Duplicate Ballot Requests must be made no later than 5:00 p.m. on Friday December 8, 2017. Requests must be made by the member directly and not via another member. You will need to say that you are with UA Local 525, and provide your name, address, and phone number. You will also need to provide your Union Member ID# OR the last four digits of your Social Security Number, for UniLect to confirm your identity.
